4 How fan coils can be used with heat pumps.

Update from Warren Clark / Troy Chambers / Barry Trewhitt

TC and WC held a meeting during early summer. TC will arrange another meeting with WC before Christmas and finalise the draft so it can be shared with all members ahead of the next meeting on 1st February.

Heat Pumps are going to be an important part of fan coil business in the near future. 45/40 seems to be the temperatures that are being specified. There has to be a compromise reached between the efficiency of the HPs and the fan coil water system. Low temperature ambient loop is being used. Propane / CO2 being used.

5 BIM / Environmental Product Declaration

Clarification from CIBSE - are they getting info from manufacturers on TM 65 and what are they planning to do with it?

Embodied carbon - CY reported that there has been a FETA webinar on embodied carbon. CY is developing a scope for a cross-HEVAC project.

BT thought it was disappointing with the lack of guidance from Government. MH said this was mirrored in Europe. France probably leading the way.

6 Guides

Generic acoustic document including a typical calculation helpful to contractors

BT, AG, JT offered to draft a simple document for members to review. Their draft was circulated to members on 20 November for review at this meeting.

There were several comments and BT amended his copy so he can produce a final draft so members can have a final review before publication.

7 Fact sheets / guidance

BT said there seem to be more schedules from consultants which contain discrepancies which is causing problems.

BT proposed this could be a suitable guide – *How to get the best out of fan coils?* Volunteers to draft the guide are: MH, TC, BT

Another guide that is needed is - Fan Coils and Air Terminal Devices
AG, chairman of Air Distribution Group will discuss this at 30/11/23 meeting & look for volunteers to work with FCU Volunteers: BT, AG, JC-S
